Sealed Tender are invited from Registered and Reputed Firms to provide CANTEEN facility for sale of tea, coffee, soft drinks of standard companies, biscuits and snacks to students in Kendriya Vidyalaya, Jhalawar, PIN-322241. Last date for submission of the sealed tenders is 22-12-2018 at 2.00 PM. Rent for the canteen is Rs. 500 per months and security deposit is Rs 1000.

- a) The contractor shall supply some note books, graph papers, maps etc at reasonable price.
- b) The taste of all foods served should be good, fresh, and palatable and without any foul or bitter feeling.
- c) The snacks / dishes should be changed every day for different tastes with different vegetables and other ingredients.
- d) The food stuffs should be properly covered, stored and served hot.

General Terms and Conditions:

1. The contract shall be valid for a period till 31/12/2019. The Contract may be extendable on mutually agreed Terms & Conditions.
2. The monthly rent quoted and agreed upon should be remitted to the Vidyalaya office on or before 10th of every month and receipt obtained.
3. The prices charged by the contractor should not exceed MRP/ Market rates.
4. The Contract is terminable by giving one month's notice in writing from either side without assigning any reason thereof.
5. Any other food requirements for meetings, Workshops, in-service courses, seminars etc. shall be on mutually agreed rates.
6. The contractor shall not Sub contract the services to other agency or individual. In all matters of interpretation or dispute relating to the Contract, the decision of the Principal/ Canteen Management Committee shall be final and binding.
7. SECURITY DEPOSIT:- The Contractor is required to deposit to the Vidyalaya an interest free Security Deposit of a sum of Rs. 1000/- (Rupees one thousand only) for the due performance of the terms and conditions of the Contract. The Security Deposit shall be remitted by way of Demand Draft along with tender form, drawn in favor of "Kendriya Vidyalaya Karali VV Nidhi, payable at Karali.
